COMSC INSTRUCTION 7210.3K

Subj: DISPOSITION OF MONEY IN REIMBURSEMENT FOR SHORTAGE AND
 DAMAGE CLAIMS

1. Purpose. To prescribe procedures for distributing proceeds from shortage and damage claims in connection with shipments by MSC subordinate commands.

2. Cancellation. COMSCINST 7210.3J.

3. Action

a. Any portion of the proceeds from cargo loss and damage, including freight claims, shall be credited to the shipper service originally charged for the freight. Amounts due the shipper services will be distributed to the cognizant offices listed below for the types of material noted:

b. At least monthly, Area Commanders will draw checks and forward them, along with copies of the associated claims, to the appropriate recipient in settlement of the claims due. The claim will contain the manifested description and price of the cargo for which reimbursement was received, the carrying ship's name, the voyage number, sailing date, the appropriate identifying accounting data if available, and in the case of the Marine Corps cargo, the specific consignee. Checks covering Air Force POV claims should be limited to no more than 40 claims each.

c. Collections for material owned by an activity and financed by nonappropriated funds, other than those mentioned above, will be made payable and forwarded directly to the nonappropriated fund activity.
